

TRMC Board of Managers

Meeting Minutes

October 15, 2025

The Titus County Hospital District Board of Managers met for a called meeting on Wednesday, October 15, 2025, at 11:30AM in the Medical Plaza Conference Room on the 3rd floor of the Titus Medical Plaza in Mount Pleasant, TX.

CALL TO ORDER: Don Lowry, Chair, called the meeting to order at 11:30AM.

Opening prayer was officiated by Dr. William Hooks. The Pledge of Allegiance was led by Andy Fortenberry.

D. Lowry, Chairman, welcomed all visitors and stated an interest in hearing and understanding the perspectives of the public. Per board agreement, the public comment period was expanded to 60 minutes and each speaker was requested to limit their comments to 3 minutes in length. A timekeeper was assigned to assist in ensuring all interested parties were heard.

PUBLIC COMMENTS FROM REGISTERED VISITORS: 144 Visitors registered to attend, with 21 of the visitors requesting to speak. There were 24 physicians/providers present of which 15 spoke. Other speakers included 4 members of the public and 3 employees. (See visitor register in Appendix 1)

EXECUTIVE SESSION: The Board convened into Executive Session at 12:46 PM with a unanimous agreement under:

- 1) Section 551.085 of the TEXAS GOVERNMENT CODE discussing or deliberating pricing or financial planning information relating to a bid or negotiation for the arrangement or provision of service or product lines to another person, information related to TRMC's Strategic Business Plan, and The Clinics of Titus Operating Reports and affiliated business purchase(s) operations.
- 2) Section 551.071 of the TEXAS GOVERNMENT CODE for private consultation with the Board's attorney.

The Board adjourned out of Executive Session at 1:30PM with unanimous agreement.

REGULAR SESSION: Regular session reconvened at 1:35PM with a unanimous vote.

- Don Lowry called for a **motion** regarding the discussion and possible action on the proposed sale, lease, joint venture, or transaction involving Titus Regional Medical Center, including discussion of possible terms of a letter of intent and other transactions documents.

- **Motion:** A **motion** was made by Ricky Baker and seconded by Tony Rundles to have the administration instructed to notify both suitors, suitor A and suitor B, that the district is interested in pursuing further discussion regarding the proposed transaction relating to the district's hospital operations as outlined in their September offers, with additional specific matters to be discussed and addressed with each suitor as determined by the administration based on discussions with the Board in closed session and that the administration will report back to the Board as soon as practical regarding the results of those further discussions.
- The motion was carried with a unanimous vote.

ADJOURNMENT: Regular session adjourned at 1:42PM with a unanimous vote.
